**PAYMENT**

After the consultation and the potential bridal client agrees to book with TamGee Artistry., the client is required to submit a 50% **\*\*NON-REFUNDABLE\*\*** deposit to secure the wedding date and times of individual bridal party members. After the 50% non-refundable deposit has been received the following payment schedule is in effect:

## RELATIONSHIP OF PARTIES

### Tamekia Geer Obligations:

Makeup Artist shall provide Services with care and skill.

Makeup Artist shall perform the Services promptly on the date and time agreed.

If Makeup Artist is unable to perform agreed services for any unforeseeable reason or unavoidable situation, Tamekia Geer cannot perform the agreed upon services due to unforeseen circumstances or any other cause beyond her control, any and all payments shall be returned to the client with the understanding that there will be no further liability with respect to the agreement.

Tamekia Geer shall use her own products in the provision of the Services

Makeup Artist will use good quality professional materials.

### Bride Obligations

Bride agrees to pay Fee in accordance with Payment provision

Bride is responsible for Tamekia Geer's fees, assistant fees, parking and travel fees.

Bride agrees to immediately inform Tamekia Geer regarding any sensitivities or allergies they may have to any types of makeup, products, or treatments.

Bride agrees to inform bridal party to inform Tamekia Geer of any sensitivities or allergies they may have to any types of makeup, products, or treatments.

## **FREQUENTLY ASKED QUESTIONS (FAQs)**

### **1.) Do you stay the entire day?**

**No, I do not stay the entire day. The bride will be gifted a touch up package (Blotting tissue, Lip gloss or lipstick) to help ensure the longevity of the makeup.**

### **2.) Do you offer just eyes and/or lip services?**

**No, I do not offer eyes and/or lip services! Full makeup applications only! No negotiations!**

### **3.) The day of the wedding, a friend/family member/bridesmaid decided she wanted her makeup done also, can she be added?**

**No, no additional person can be added the day of the wedding. It creates stressed time and interrupts the flow of appointments. Only persons discussed prior (2-4 weeks) before the wedding will be included.**

Please Note:

**CANCELLATION POLICY**

Cancellations must be made seven (7) days prior to your reserved date or you will be responsible for the amount of services agreed upon in this contract. Any cancellation on the appointment date without 72 hours notice will be charged the Full Price of services scheduled

**EARLY/DELAYS FEES:**

An early start fee of \$50 will be charged if we are required to start earlier than 7am.

A late fee of \$25.00 will be charged for every 30 minutes of delay when a client is late for the scheduled time, or if scheduled makeup exceeds allotted time because of client delays.

Any no-shows on the appointment date will be charged the full price of services scheduled

**SERVICE LOCATION AND REQUIREMENTS:**

Location of service for the day-of-event will be at the discretion of the client, but there are certain requirements the makeup artist needs to complete the makeup applications. A “set up” table/work area needs to be made available for the makeup artist at said location. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly.

**PARKING FEES:**

If paid parking applies. Please arrange for hotel parking or have some extra cash to cover the meter fee for your make-up artist.

**LIABILITY:**

All brushes and makeup products are kept sanitary and are sanitized between every makeup application. Makeup products used are hypoallergenic. Any skin condition should be reported by the client to the makeup artist prior to application. Client(s) agree to release the makeup artist (Tamekia Geer) should a reaction occur, requiring medical attention or not, it is agreed that the Makeup Artist is not legally liable or responsible for injury and/or ailment of any kind.
